

# Terms of use

## 1. Subject

These Terms of Use constitute an agreement between you and the administration of the website [navalny.memorial](https://navalny.memorial) (hereinafter referred to as “the Website”) regarding access to and use of the Website, as well as any other media platform, channel, mobile website, or mobile application associated with the Website (collectively referred to as “the Website”). The Website provides a service for organizing a competition. In order to ensure a safe environment on the Website, all users must accept and comply with these Terms of Use. By accessing the Website, you agree that you have read, understood, and accepted these Terms of Use.

1.2. All users who are minors in the jurisdiction in which they reside (typically under 18 years of age) must have permission from and be under the direct supervision of their parents or legal guardians to use the Website. If you are a minor, you must ask your parent or legal guardian to read and agree to these Terms of Use before you begin using the Website.

1.3. These Terms of Use govern the conduct of the competition for the design of a monument for Alexei Navalny’s grave at the Borisovskoe Cemetery in Moscow (hereinafter referred to as “the Competition”).

## 2. Competition dates and procedure

2.1. The Competition will take place from December 5, 2024, to February 16, 2025, inclusive:

- From December 5, 2024, to January 31, 2025 — submission of design for Alexei Navalny’s monument.
- From February 1 to February 3, 2025 — selection of the three finalists.
- February 4, 2025 — publication of the designs of the three finalists on the Website.
- From February 4 to February 15, 2025 — voting on the Website to choose the best memorial design of the three finalists.
- February 16, 2025 — announcement of the results and publication of the winner’s work.

2.2. The competition dates may be changed at the discretion of the organizer.

2.3. Submission Requirements and Guidelines:

2.3.1. Designs must be submitted to the email address [memorial@navalny.com](mailto:memorial@navalny.com)

2.3.2. The design should comply with the technical requirements posted on the Website.

2.3.3. By submitting a design, you consent to the processing and publication of your name as the author of the work. If you do not wish your name to be published, please explicitly and clearly indicate this in your email when submitting the design.

2.3.4. Plagiarism or the use of third-party works, as well as violations of copyright or other legal rights, are prohibited.

2.4. Main criteria for evaluating the works:

- Quality and professionalism of the work from an artistic perspective;
- Originality of the individual approach;
- Imagery;
- Emotionality;
- Expressiveness;
- Color schemes.

2.5. The practical implementation of the design or its underlying concept, including the choice or modification of the design, material, size, form, color, or other parameters of the monument, remains at the discretion of the Competition organizer.

2.6. No prize money is provided for winning the competition.

2.7. These Terms of Use do not constitute an obligation to enter into a contract with the winners of the Competition under the terms of Article 1057 of the Civil Code of the Russian Federation.

## 3. Intellectual property rights

3.1. Unless otherwise specified, the Website, its content, including source code, databases, functionalities, software, design, audio, video, text, photos, and graphics (collectively referred to as “Content”), trademarks, service marks, and logos are our intellectual property, owned by us, controlled by us, or licensed to us, and are protected by intellectual property laws, copyright, and trademark conventions.

3.2. We respect the intellectual property rights of others. If you believe that any material available on the Website or through it infringes on your copyrights or other rights you own or control, please notify us immediately using the contact information provided below.

3.3. The exclusive rights to the intellectual property created during the Competition are transferred to the Competition organizer. The transferred exclusive rights allow the organizer to use the works in any form and by any legal means.

## 4. Payments

4.1. In this case, the donor agrees to provide accurate and complete information for all necessary transactions. You also agree to update relevant information, including your email address and payment method, so that we can contact you if needed.

## 5. User data

5.1. We will store certain data that you provide to the Website, including data related to the operation of the Website, such as your chosen username, email address, or payment information. By providing this data, you consent to its processing, which includes actions such as collection, storage, updating, use, transmission (dissemination, provision, access), anonymization, blocking, deletion, or destruction of personal data.

## 6. Cookies

6.1. Our Website uses cookies to recognize repeated use of the Website by the same user or internet connection. Cookies are small text files that your web browser downloads and stores on your computer. They are used to improve our Website and the services provided by the services on the Website. Most of these are temporary cookies that are deleted after you leave our Website.

6.2. However, some cookies transfer information used for automatic user recognition via the IP address saved in the cookies. The information collected in this way is used to improve our services and speed up your access to the Website.

6.3. You can disable cookies by changing your browser settings. However, please note that by doing so, you may not be able to fully use all the features of our Website.
